We could send Meghan the issues and concerns and then she will forward to Sandy. Meghan will invite Greg Smith to our next meeting. Work order re: hitched trailers is currently being worked on(Smith's side of the area). SLO Sue Harold showed up. Props to her. No letter will be submitted by JJ to the station. She will be present when she is able to. SLO is requesting that she be notified. Café O on Vanowen and De Soto area. SLO needs help with this store. Corbin area two guys were stabbed. Three male Hispanics. Graffiti problem call police when you see suspicious activity. Area on Roscoe and Winnetka Stop N Go store. Can call 911 for the refrigerators are dangerous for the kids in the area. Recycling center is now up front and not in the back. This issue will be added to the agenda for the Public Safety meeting in April. The business is causing problems in the area. They were told to move in back of Jon's but Jon's does not want them in the back. Penfield is being worked on. Half way house on Mason and Roscoe Blvd. Third Thursday of the month is her Basic car meeting at Devonshire Station at 7 pm.

They are active and are not involved in street delinquency. All of the girls are doing exceptionally well in their school academics and keep themselves occupied every day. A priority list was provided to the board members as far as the supplies that are needed to run this type of program. JJ motioned to support up to \$1300.00 and Josef seconded. All approved.
- 8. Jim Rojas from Tarzana Landscaping to discuss landscaping ideas for the Sherman Way median. Not present.
- 9. Swearing in of new Youth Member, Stephanie Aguirre. Not present.
- 10. Discussion and possible action on supporting the six river rocks installation on each left hand turns at the Sherman Way median. Sims discussed the Tarzana Nursery Landscaping which will provide the river rock and flowers that will be placed on the six left hand turn lanes on the Sherman Way Median where the signal lights. Erick motioned to support up to \$25,000,00 which will include the material and labor (including the river rock from another distributor) and TJ seconded it. All approved.
